CALL SPECIAL MEETING TO ORDER

The special meeting of the Board of Trustees was called to order at 7:01 p.m. by Mr. Carlos Früm.

APPROVAL OF THE AGENDA

Mr. Lonoff moved to approve the agenda. Ms. Young seconded the motion. On a voice vote, all Trustees voted "aye."

NEW BUSINESS

Friends of the Library Meet and Greet

Ms. Hall opened the meeting with a brief introduction and purpose of the two Boards coming together. After Ms. Hall's introduction, there was a brief period of socializing where the attendees mingled and enjoyed refreshments. Mr. Austin then facilitated an icebreaker in which attendees introduced themselves and shared why they love the library. After introductions, there were small group discussions about why each attendee serves on their board and their individual motivations of why they volunteer.

After the small group discussions, a brief presentation was given to explain the role of each group to the library. Mr. Früm explained the Library Board of Trustees role is to govern, set policy, and oversee the finances; Mr. Schildgen discussed the Friends of the Library's role as a supportive mechanism for the library's programming; Ms. Xu spoke about the Foundation's role which is to solicit large scale donations; and lastly, Ms. Hall spoke about the role of the Library staff, which oversees the day to day operations of the library.

After brainstorming as a large group, time was given for individual reflection in which the smaller groups discussed ways in which the two boards can help each other. The meeting ended with Mr. Austin leading a large group sharing to summarize all the ways that the two groups can collaborate moving forward.

Ms. Hall identified the next steps as scheduling another meeting between the Friends of the Library Board and the Library Board of Trustees in the Fall of 2019 along with sharing of meeting Minutes between the two Boards.
